

**2026 Catch You There
Giveaway
Complete Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PRODUCT PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. ELIGIBILITY: The 2026 Two-Hearted Summer Giveaway (“Promotion”) is offered and open only to legal residents of the 50 United States and DC who are age 21 or older at time of entry. Void where prohibited. Employees, officers and directors of Bell’s Brewery (“Sponsor”) and those entities involved in the preparation of materials and/or administration of this Promotion (collectively with Sponsor referred to herein as the “Promotion Entities”), suppliers, distributors, or retailers of alcohol-beverage products, and their immediate family members (spouse, siblings, children and parents) and those living in the same household as such individuals (whether or not related) are not eligible to enter.

2. PROMOTION PERIOD: Promotion starts on or about 12:00:01 am Mountain Time (“MT”) on May 1, 2026, and ends 11:59:59 pm MT on August 31, 2026 (“Promotion Period”). All time referenced herein is Mountain Time. Sponsor’s clock is the official time keeping device for the Promotion.

3. HOW TO ENTER: There are three (3) ways to enter:

- **Entry Method #1 (Website):** During the Promotion Period, access bellsbeer.com/CatchYouThere (“Website”) or scan the unique code on the Promotion materials to access the Website, and follow the online directions to register and submit an entry (“Website Entry”). Only website entries with a valid state, eligible date of birth, contact information, and retail location will receive one entry into the applicable sweepstakes drawing. Website entries must be received during the Promotion Period.
- **Entry Method #2 (Postcard):** During the Promotion Period, obtain a pre-printed and addressed, postage affixed post card from Sponsor at Sponsor event, and legibly complete entry information on the postcard (“Postcard Entry”). Only postcard entries with a valid state, eligible date of birth, contact information, and retail location will receive one entry into the applicable sweepstakes drawing. **All mail-in entries must be postmarked by August 24, 2026 and received by August 31, 2026. Requests for confirmation of receipt of mail-in entries will not be acknowledged.**
- **Entry Method #3 (Social):** During the Promotion Period, log in to your Instagram account and (i) follow @twohearted (Instagram.com/twohearted); (ii) like the Promotion post; and (iii) comment on the Promotion post by tagging your summer

camp friends with the @ symbol and use hashtag @DrinkTwoHearted.

Any attempt by any person to obtain more than one entry by using multiple/different phone numbers, accounts, devices, physical addresses, email addresses, identities, registrations, entry methods, or any other methods will void that person's entries and they may be disqualified from this Promotion or any current or future promotions offered by the Sponsor, in its sole discretion. Use of any automated system, software applications that enable users to create multiple accounts and/or temporary accounts to participate in this Promotion or to redeem prizes is prohibited and may result in disqualification from this Promotion and any current or future promotions offered by the Sponsor. In the event of a dispute as to any entry, the "Authorized Account Holder" of the phone number or email address associated with the account at time of entry will be deemed to be the entrant. 4. SELECTION OF WINNER(S): Sponsor will conduct six drawings (two drawings per entry method) on or about September 1, 2026 from all eligible entries received by 11:59:59 p.m. MT on August 31, 2026, to select six (6) Grand Prize winners (two (2) Grand Prize winners per entry method). Odds of winning depend on the number of eligible entries received from each entry method prior to the drawing. All entries and participation in this Promotion shall be governed by these Official Rules and the decisions of the judges and Sponsor, whose decisions shall be final, binding, and conclusive on all matters. The potential winner will be contacted by telephone or text at the telephone number provided at the time of entry, or at the email address provided at the time of entry, within 5 business days after the drawings.

- Round trip travel, including two (2) economy class round-trip airfares (if needed) from the Grand Prize winner's home airport to Michigan (Transportation to/from winner's home airport and any baggage fees are all winner's responsibility) at a date determined by the Sponsor.
- Two (2) night stay at a selected fishing lodge. Location and date to be determined by the Sponsor.
- All food provided by local chefs.
- Camp activities.

Approximate Retail Value of each Grand Prize: \$2,000. Actual value depends on city/day/time of flight departures.
